## APPLICATION FOR ASSOCIATE MEMBERSHIP

The undersigned hereby applies for membership in the Air Diffusion Council, a corporation incorporated under the General Not For Profit Corporation Act of the State of Illinois. The undersigned hereby designates the person indicated below to represent it and to receive notice of meeting of members of the Council.

We understand that the provisions for Associate Membership in the Air Diffusion Council as defined by the By-Laws are as follows:

“Any person, firm or corporation furnishing products for sale to the HVAC Flexible Air Duct (metallic or non-metallic) Industry manufacturers are eligible to become Associate Members of the Council. To assist in determining such qualifications, the applicant shall list below the products, furnished for sale to the Flexible Air Duct Industry manufacturers.

Associate Members shall be entitled to all rights and privileges of Members, except the rights to vote, to serve as an officer of the Council.

We further understand that there is an annual membership fee and that there will be two special hospitality assessments annually. Application for Associate Membership must be on this form supplied by the Council, accompanied by payment of the annual membership fee (\$650.00)

Upon receipt of this application, the application shall be reviewed and notice of application published to the membership. Associate Membership applications are submitted to the membership and upon a majority vote of the membership, the applicant shall become an Associate Member.

The membership may, for cause it determines adequate, terminate the membership of an Associate Member by a majority vote of the members; but such action shall not be taken unless the Associate Member has been notified in writing of such cause and given an opportunity to be heard.

Any Associate Member may terminate his membership at any time by notifying the Council headquarters, in writing, of the date he wishes membership to cease. Such termination shall not, however, relieve the Associate Member of the obligation to pay any dues or assessments theretofore accrued and unpaid; or any obligations to the Council performed prior to termination of membership.

The undersigned hereby states his belief that the applicant firm qualifies for Associate Membership on the basis of the above qualifications for membership; and agrees that, upon acceptance of this application, he will abide by the above conditions as set forth in the Council By-Laws.
